RANDOM DRAW If the entry limit for the trial is exceeded during the Random Draw Time Period, a random draw will be held on Thursday, October 2, 6 pm at Starbucks 2000 El Camino Real, Palo Alto, CA 94306. Belgian Tervuren have preference and up to three worker spots may be held.

WORKER SPOTS Up to three worker spots may be available for workers as needed. All workers are assigned and confirmed by the trial chair. A worker spot entitles the worker to one confirmed entry as defined by AKC. Additional entries for a worker will go into the random draw.

ENTRIES CLOSE Wednesday, October 15, 12:00 PM at the address of the Trial Secretary, after which time entries cannot be accepted, canceled, or changed, except for as provided in Chapter 1, Section 16 of the AKC Obedience Regulations.

WAIT-LIST RBTF is offering a wait-list to fill openings created by withdrawn entries before the trial's closing date/time. No entries may be withdrawn with a refund after closing, except for bitches in season. Any wait-listed entry that does not move off the wait-list into the trial will receive a full refund.

ILLEGIBLE ENTRIES will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

BITCHES IN SEASON Full refund, less a \$10 processing fee will be given for bitches in season after the closing date. A written request is required to receive a refund and the request must be received by the Trial Secretary no later than 24 hours prior to the start of judging.

DOG OWNER A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section). Dogs listed in the AKC Canine PartnersSM Program should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants. AKC Rules, Regulations, Policies and Guidelines are available on the American Kennel Club website: www.akc.org

TRIAL RULES

- **MAIL ONLY ENTRIES**---to be acceptable, submit entry, with the required entry fee, on an official AKC entry form, or copy, including the agreement and instructions. Please type or neatly print.
- The club assumes no responsibility for a wrong entry.
- Entries without fees cannot be accepted. Entries specifying any condition as to acceptance cannot be accepted. Unsigned, incomplete, telephone, fax or email entries will not be accepted.
- The owner is responsible for errors on entry forms, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors. No dog wrongly entered in a class may be transferred to another class after close of entries. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Changes by telephone are not acceptable.
- Entries will receive an email confirmation within 7 days after receipt. If acknowledgments are not received by an exhibitor 7 days prior to the Trial, please notify the Trial Secretary.
- Consult Judging Schedule for time of judging.
- Exhibitors and handlers alone are responsible for the presence of their dogs in the judging ring.
- The Club and the Trial Secretary assume no responsibility in this regard.
- The Club will exercise every precaution for the safety of dogs exhibited, but it must be understood that the Club will not be responsible for loss or injury.
- Dogs must be kept on leash except when in the judging ring.
- There shall be no drilling, intensive or corrective training of dogs on Trial grounds or premises.
- In case of a tie for any prizes, any dog that is not present for a run-off forfeits the right to the prize.
- Entry fees will not be refunded in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, loss of site, or other acts beyond the control of the Club, or if it is impossible to open or to complete the Trial, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to hurricanes, lightning, extreme heat or earthquakes, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the Trial before completion, no refund of entry fees will be made.
- **MOVE-UPS (Class Transfers)** will be permitted in accordance with Chapter 1, Section 16 of the Obedience Regulations. Please notify the Trial Secretary in writing as soon as possible, but at least 30 minutes prior to judging.
- **BITCHES IN SEASON** are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than 24 hours prior to the start of the first class, then the Club will refund the entry fee, less a \$10 processing fee.

Grounds rules:

- A CLEAN towel and/or CLEAN mat must be placed under your CHAIR and CRATE to crate in the building
- NO X-pens in the building.
- NO crate aggressive dogs in the building.
- Unentered dogs are not allowed in the building.
- NO overnight & NO day of RV parking.
- NO smoking allowed on the grounds.
- You will not be allowed to leave your vehicle idling in the parking area.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.
- Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts.
- All dogs must be ON-LEASH at all times while on show grounds and parking areas unless in the ring for judging. Retractable leashes (Flexileads) are permitted, but may not to be extended beyond 6 feet in length indoors.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Consult the judging schedule for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
