- -Entries without fees cannot be accepted. Entries specifying any condition as to acceptance cannot be accepted. Unsigned, incomplete, telephone, fax or email entries will not be accepted.

- 2. NO smoking allowed on the grounds.

- 4. Check in will be done outside the building.
- **5.** Bring canopies and/or shade cloth. Please keep dogs quiet, if barking cannot be controlled you will be asked to leave. Keep dogs on leash while not working. Note: farm animals and cats on property. Air (potty) your dog on gravel driveway. Do not air on grass, plants, barn or equipment. Note: water is well water and safe to drink.
- 6. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
