**MAIL ENTRIES.** Make checks payable to Redwood Belgian Tervuren Fanciers Inc. (RBTF Inc) and mail to Karey Krauter, 374 Stanford Ave, Palo Alto, CA 94306. Receipt of mailed entries will be confirmed by email if an email address is provided on entry form.

**RANDOM DRAW.** If the entry limit for the trial is exceeded during the Random Draw Time Period, a random draw will be held on **Wednesday Nov 23 at 9 pm** at Starbucks 2000 El Camino Real, Palo Alto, CA 94306. Belgian Tervuren have preference and up to three worker spots may be used. Workers, per AKC regulations, are selected by the club and will be notified.

**ENTRIES CLOSE Wednesday, Dec. 7 at 12PM** at the address of the Trial Secretary, after which time entries cannot be accepted, canceled, or changed, except for as provided in Chapter 1, Section 16 of the AKC Obedience Regulations.

**WAIT-LIST** - RBTF is offering a wait-list to fill openings created by withdrawn entries before the trial's closing date/time. No entries may be withdrawn with a refund after closing on Dec. 7th at 12:00 pm, except for bitches in season. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait-list into the trial will receive a full refund.

### **Entries will be refunded if the show is canceled due to COVID 19.**

Illegible entries will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

Bitches in season: Full refund, less a \$10 processing fee will be given for bitches in season after the closing date. A written request is required to receive a refund and the request must be received by the Trial Secretary no later than 24 hours prior to the start of judging.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section). Dogs listed in the AKC Canine PartnersSM Program should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants. **ADDITIONAL TRIAL RULES**

MAIL ONLY- To be acceptable, submit entry, with the required entry fee, on an official AKC entry form, or copy, including the agreement and instructions. Please type or neatly print.

- The club assumes no responsibility for a wrong entry.
- Entries without fees cannot be accepted. Entries specifying any condition as to acceptance cannot be accepted. Unsigned, incomplete, telephone, fax or email entries will not be accepted.
- The owner is responsible for errors on entry forms, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors. No dog wrongly entered in a class may be transferred to another class after close of entries. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Changes by telephone are not acceptable.
- Entries will receive an email confirmation following the draw, if an email address is provided on the entry form, otherwise, the confirmation will be sent via USPS standard mail.
- Consult Judging Schedule for time of judging.
- Exhibitors and handlers alone are responsible for the presence of their dogs in the judging ring.
- The Club and the Trial Secretary assume no responsibility in this regard.
- The Club will exercise every precaution for the safety of dogs exhibited, but it must be understood that the Club will not be responsible for loss or injury.
- Dogs must be kept on leash except when in the judging ring.
- There shall be no drilling, intensive or corrective training of dogs on Trial grounds or premises.
- In case of a tie for any prizes, any dog that is not present for a run-off forfeits the right to the prize.
- Entry fees will not be refunded in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, loss of site, or other acts beyond the control of the Club, or if it is impossible to open or to complete the Trial, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to hurricanes, lightning, extreme heat or earthquakes, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the Trial before completion, no refund of entry fees will be made.
- MOVE-UPS (Class Transfers) will be permitted in accordance with Chapter 1, Section 16 of the Obedience Regulations. Please notify the Trial Secretary in writing as soon as possible, but at least 30 minutes prior to judging.
- BITCHES IN SEASON are not permitted to compete. If a female is withdrawn from competition for coming into season after the closing date and the Trial Secretary is notified no later than 24 hours prior to the start of the first class, then the Club will refund the entry fee, less a \$10 processing fee.

Rules for entering this trial:

**DO NOT COME IF YOU FEEL SICK!!! (If the club is able to fill your entries from the wait-list, your entry fees will be refunded.)**

**Grounds rules:**

1. NO overnight & NO day of RV parking.
2. NO smoking allowed on the grounds.
3. You will not be allowed to leave your vehicle idling in the parking area.
4. Check - in will be self serve outside the building.
5. Crating may be allowed in the building. If it is you must bring a clean blanket or towel to put under the crate. No X-pens allowed in the building. Please be careful of the matting while putting up your crate.
6. No crate aggressive dogs allowed in the building. Please be quiet and respectful of those in the ring.
7. Please keep dogs quiet, if barking can not be controlled you will be asked to leave the grounds. Keep dogs on leash while not working. Note: farm animals and cats on property. Air (potty your dog on gravel driveway. Do not air on grass, plants, barn or equipment.
8. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this rule. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
9. You will be required to wear a mask in the building and may be required to wear it while competing in the ring (judges discretion).

Covid 19 - best practices:

1. Participants are required to follow state, local and facility guidelines that are in effect at the time of the event.
2. You will be required to wear a mask while in the building. You may not enter the building if you are not wearing a mask. Wearing of a mask while competing is up to the judge. You must bring your own mask.
