**CLOSING DATE:** Entries will be accepted until 6:00 p.m. on Thursday, January 22, 2026, after which time entries will not be accepted, canceled, altered or substituted. Overnight and express mail entries **MUST** specify **NO SIGNATURE REQUIRED**.

**ENTRY FEES:** TD - \$75.00, TDX - \$125.00. A \$4.50 recording fee is included in each entry and will be forwarded to the AKC per CH 11, Sec. 2 of the AKC Rules and Regulations. Make checks payable to **RBTF, Inc**.

**TD ELIGIBILITY**: Test is limited to **3** dogs with appropriate Certification or have previously passed a TD or TDU test. Each entry for a dog that has not previously passed an AKC TD/TDU test must be accompanied by a written statement, dated within one year of the date of the test, signed by a person approved by the AKC to judge tracking tests, and must certify that the dog has satisfactorily performed a certification test.

**TDX ELIGIBILITY:** TDX entry is limited to **2** dogs that have previously passed a TD, TDU, or TDX test. See entry drawing order below.

**EXCHANGE OF TRACKS**: If the limit for entries is not reached in either the TD or TDX test IN THE PREFERRED BREED OF TERVUREN and the other is exceeded, the number of tracks offered may be exchanged on the basis of two (2) TD tracks for one (1) TDX track. Further, if the limit for entries is not reached in either the TD or TDX test for NON-TERVUREN and the other is exceeded, the number of tracks offered may be exchanged on the basis of two (2) TD tracks for one (1) TDX track.

**ENTRY DRAWING**: A random drawing of all entries received by the closing date and time will be held to determine the participants in the test. The drawing will be held on **Thursday**, **January 22**, **2026** at **6:30** p.m., at Starbucks, 2000 El Camino Real, Palo Alto CA 94306.

The order of draw shall be in accordance with **Chapter 1**, **Section 17** of the Tracking Regulations. This Test is open to all AKC-registerable breeds of dogs as per the section above, however, the draw for entries will be done for the respective tests in the following order:

- 1 Belgian Tervuren without a TD/TDU/TDX
- 2 Belgian Tervuren with a TD/TDU/TDX
- 3 Other breeds without a TD/TDU/TDX
- 4 Other breeds with a TD/TDU/TDX

**ALTERNATE LIST:** An alternate list will be maintained and will consist of entries received by the closing date but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for entries that are to run.

**NOTIFICATION:** Notification of the draw results will be made by email as soon as possible after entries have closed. Should such notification not be received by the exhibitor within a reasonable time, please contact the Test Secretary.

**DRAWING FOR RUNNING ORDER** - All dogs and handlers must be at the test HQ by the designated times shown below on **Sunday**, **February 1**, **2026**, at which time there will be a draw to determine the running order. Entrants not present at the time of the draw will be marked absent and an alternate will be allowed to run in their place.

TD - 8:00 a.m., TDX - 10:30 a.m.

**AWARDS:** A qualifying rosette ribbon for each passing team.

**BITCHES IN SEASON** may participate in the test. Handlers are asked to park well away from the other vehicles and to notify the Secretary that your entered bitch is in season. They will be allowed to participate after all other dogs and bitches not in season have been tested. The last track will be for the bitch in season. If there is more than one bitch in season, there will be a separate draw for these bitches.

**DOGS ON LEASH:** Dogs must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and the withholding of any awards.

**DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES.** If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the bench show Committee for disciplinary action. All persons attending this show hereby waive any claim against RBTF and its members, in the event a motor vehicle must be entered to rescue a dog from over-heating or suffocation due to improper ventilation.

**RISK:** The owner or agent entering a dog in a Tracking Test does so at his/her own risk and agrees to abide by all the Rules and Regulations of the American Kennel Club. RBTF assumes no responsibility for any personal injury or death of any person; theft of personal property; theft, injury or death of any animal; or any loss of or damage to any property while at this test or on the test site or in transit to/from the site.

**VACCINATIONS:** Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites and communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California.

**ARBITRATION:** This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

**REFUND POLICY:** The entry fee shall be refunded to any entrant if the secretary is notified prior to the draw of such withdrawal and an alternate is available to run the track, and for all alternates not given the opportunity to run a track.

**TEST HOURS:** 6:30 a.m. to 3:00 p.m.. Judging will begin as soon as tracks have aged sufficiently.

# **NEW Location for "Headquarters"**

From Highway 50 - Exit Zinfandel Dr. Travel south on Zinfandel Dr. Turn right onto Douglas Blvd. At the stop sign, (Mather Blvd.), turn left. Turn left onto Convair Liner Rd. (yellow gates). There are no restroom facilities at this location. Facilities are located at Mather Regional Park (Zinfandel Dr.), Mather Golf Course (Zinfandel Dr.), or local park (10949 Britton Way, Mather, CA).

There are no restrooms at the test headquarters. Plan on using the restrooms at the Mather Rotary Park (old HQ, be aware of the parking fee), or at the Mather Golf Course, or at Veterans Park on Excelsior Rd a mile past Convair Liner Rd. Please plan on using restrooms prior to your arrival, as entry/exit access to Convair Liner Rd will be limited once testing has begun.

**SPECTATOR/DRIVING ACCESS**. We are no longer officially allowed any vehicle access on any of the interior roads. We will likely need to drive to the west side of the park when staging for some of the tracks, and there is likely to be a significant walk for exhibitors and spectators (if allowed) into and out of the areas. In addition, the area available for exercising dogs during the event has changed - please look for marked area and/or inquire before exercising your dog at the site.

**PRACTICING:** Limited practicing on the test site is permitted with these restrictions. No training on the grounds is permitted on the day of the test. Please refrain from using the fields at least 3 days before the test. Please respect all "No Dogs" posted signs.



# **IMPORTANT - 10-DAY RULE**

- No exhibitor may show a dog under a judge at a tracking test if the exhibitor
  has participated in a training session taught by that judge within ten (10) days
  prior to the date of the event (Chap 1, Section 12, paragraph 8).
- People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid a track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler. The judges will determine the order in which the tracks are run and the number of each track. (Chap 2, Section 9, paragraph 4).
